Benefits of being an IOGA member

The Independent Oil and Gas Association of Pennsylvania provides many benefits to member companies. In today's regulatory and political environment, it is difficult for an individual company to be aware of every state and federal regulation and statute. It is even more difficult for an individual company to impact the regulatory community in an effort to achieve some measure of relief.

IOGA serves as a clearinghouse for Pennsylvania producers' awareness of issues impacting their businesses. Through IOGA communications, newsletters, emails, and meetings, producers become aware of changes in regulations early enough to have some response to the government agencies promoting these changes before they become "carved in stone". IOGA staff and committees work with regulators to achieve workable solutions to problems. IOGA works to inform legislators and develop legislation that is hopefully more meaningful and less onerous for our industry.

IOGA was active in the gas deregulation discussions in Pennsylvania. We were the only group at the table that truly attempted to protect the interests of Pennsylvania producers. IOGA monitors activities at the PUC that directly affect producers, and provide a mechanism for member companies to become involved in PUC cases without having individual exposure. Group efforts at the Commission lessen the chance of utility company retribution against individual companies. At the federal level we have provided comments to the FERC on interstate pipeline issues and deregulation issues that affect PA producers.

IOGA has constant involvement with environmental issues on both state and federal levels. IOGA has long been aggressively addressing the requirements for NPDES permits for oil and gas activity. Although EPA finally recognizes all of our activities are exempted, we now are involved in fighting an identical state-mandated program in Pennsylvania. Such environmental mandates can have serious financial consequences to producers as well as cause significant operational delay. We also work with member companies on local problems, such as zoning and taxation, which tend to become statewide problems if left alone.

The association is member-driven. The issues that we monitor are those with which the members are most concerned. Through the committee structure, companies have a mechanism to share ideas, concerns, and solutions. IOGA is in summary a solution-oriented organization, which attempts to help members accomplish that which they may not be able to achieve alone.
